Transitions in 2015, Growth for 2016

The retirement of longtime Executive Director George Reed and arrival of new ED Jennifer Copeland made 2015 a year of significant transitions for the NC Council of Churches. Reed's departure came after almost 20 years with the Council, first working on its legislative program before stepping into the leadership role. After 16 years as the United Methodist chaplain at Duke, Copeland became the Council's first female executive director.

Reed and Copeland worked together to insure the Council's work was uninterrupted. Indeed, new initiatives were begun in 2015 and additional staff hired to extend and deepen programming.

In cooperation with Health Care for All NC and with funding from the Kate B. Reynolds Charitable Trust, Liz Millar was hired for a six-month role to work on Medicaid expansion through faith communities specifically in economically challenged, Tier 1 counties. Liz is currently finishing her Master in Public Health degree at UNC-Chapel Hill.

And Chris Pernell joined the Partners in Health and Wholeness Program where she now serves as Program Coordinator. She had most recently worked for a faith-based, nonprofit medical clinic serving the uninsured and under-served of Franklin County.

The Council re-engaged with partner organizations to work against changes in federal law that could prompt the return of payday lending to the state. And the Council renewed its work against gun violence as part of a coalition of primarily Triangle-area groups. Among those efforts that have carried over into 2016 are plans for the creation of faith-based resources and the commemoration of the first anniversary of the shootings at Mother Emmanuel African Methodist Episcopal Church in Charleston.

Already 2016 has been a busy year. North Carolina Interfaith Power and Light coordinated a speaking tour by Katharine Hayhoe, an internationally know climate

scientist who is also an evangelical Christian, on why people of faith must be involved in care of creation.

Additional expansion of PHW continued with the hiring of two new regional coordinators who will begin work in May in the far western and northeastern parts of the state thanks to funding by the Blue Cross Blue Shield of North Carolina Foundation and The Duke Endowment.

The annual Farmworker Institute takes place on April 21 in Chapel Hill, bringing together advocates from across the state who will have the chance to learn from and update one another on the latest issues affecting farmworkers

In March, the Council found itself among those opposing House Bill 2 as discriminatory and hateful. In partnership with EqualityNC and the Equality Federation, the NCCC is co-sponsoring a panel on Christian ethics and HB2 featuring David Gushee, T. Anthony Spearman, and William Meyer. That takes place on Sunday, April 24. And one day prior, the Council holds its biennial Critical Issues Seminar, with this year's focus on Race, Power, and Privilege. George Reed will receive the Council's Distinguished Service Award at the event. Details about the seminar are on page 5 and information about other upcoming events is on page 6.

Immigration & Farmworkers

www.welcometheimmigrant.org www.ncfarmworkers.org Our successful **clergy breakfasts** continued across the state and the **2015 Faith & Immigration Statewide Summit** focused on issues affecting children and youth. We expanded our work: hosting an **interfaith prayer vigil for refugees and community potluck** and coordinating an **photography exhibit** with Pulitzer Prize winner José Galvez, whose work focuses on Latino life in NC. Most of December and January was dedicated to **ACA outreach** to our Latino brother and sisters. We created and distributed bulletin inserts in Spanish and English about the Health Insurance Marketplace, organized two enrollment events in rural areas, and our work was shared by the Public News Service.

In our work to improve physical health within faith communities, 236 Strive to Revive congregations have received automated defibrillators for their facilities and in 2015 PHW made maintenance and training grants available to AED recipients. We also certified 39 congregations at either the bronze, silver, or gold level and awarded \$28,760 in mini-grants. In addition, generous funding from the Blue Cross Blue Shield of North Carolina Foundation and The Duke Endowment will allow us to expand our programming statewide with regional coordinators in the western and northeastern corners of NC.

NCIPL was a leader in a number of activities and events focused on the **encyclical by Pope Francis** on care of creation. We advocated on behalf of **clean renewable energy policies** and for the Environmental Protection Agency's **Clean Power Plan**. We worked with **Audubon NC** to provide climate ambassador trainings, provided faith-based analysis of the **Paris Climate Talks**, and partnered with Mom's Clean Air Force to hold a **Playin' and Prayin'**, family-focused event highlighting our moral call to protect the health of our children and the environment.

Along with *Raleigh Report*, our periodic newsletter published throughout the General Assembly session, we also continued to publish a weekly *E-news* letter with information from all our programs and from like-minded organizations. In 2015, we also held our *Legislative Seminar* to equip people of faith to be grassroots advocates around issues they care about. We partnered with other organizations for a strong federal law to keep *payday lending* out of North Carolina, to *expand Medicaid*, and to collaborate against *gun violence*. Our lectionary-based *Advent Guide* took as its theme the plight of our refugee sisters and brothers. And we entered into a partnership with the *Public News Service* to bring broader attention to the Council's areas of work.
